Online filing of Annual Statements, started in 2014, is a positive step in this direction with 31,028 registered publications including 1,472 Miscellaneous publications filing their statements for the year 2016-2017.

Encouraged by the successful implementation of e-filing of Annual Statements, digitalization of title application and registration processes are also in the offing. The other services that are already in place include facility to view online the status of title verification and registration, and list of existing and de-blocked titles, sending status update of applications through SMS and e-mail, online download of Certificate of Registration and an effective Public Query Response Cell to help publishers, especially in far-flung places to redress their grievance quickly. As part of the modernization plan, the official website of RNI is being given a facelift in design. I urge all the publishers and other stakeholders to optimize the use of our website and help us to provide services in a speedy and accurate manner. Constructive suggestions from publishers are welcome.

We sincerely hope this report will help to print media, media analysts and research scholars to get hold of data on print media in the country. We expect 'Press in India' to serve as a guide for aspiring publishers and public in general.
